1. Opening of the Meeting

2. Adoption of the Agenda

3. Review of Minutes from the SHE 50 and 51 Meeting

In the Minutes from SHE#50 the agenda item 9, the specific exclusion criteria for hotspot A3-1, was missing in the list of tasks for follow-up on. This will be reintroduced on the list.

5. HEG meeting in Murmansk (Maria Dronova)

Maria has been in contact with Murmansk about the HEG meeting. Murmansk region (Ministry of Natural Resources) is positive to arranging such a meeting in March 2017 and will develop a draft program. It was stressed that the dates for the HEG meeting should be decided as soon as possible. Maria will try to settle the dates by the end of the year 2016
