#### 4. Review of Minutes from previous meetings

Review and comments on/approval of the minutes from SHE #80 and SHE#81
The minutes for SHE #80 and #81 were approved by the whole SHE-group (Alexander confirmed via e-mail after the meeting).

# 5. Up-date on Correspondence with the Regional Hotspot Exclusion Groups (Regional HEGs)

- a) Follow-up on response from the regional HEGs regarding their readiness for conducting HEG meetings in the regions/or on telephone
  - i) Komi: Åke reported that he had got an e-mail from Komi (Ms Tatiana Tiupenko) with questions regarding dates for the ministerial meeting and requirements for preparation of hotspot documentation.
  - ii) Murmansk: The Chair also reported that he during the visit to Murmansk in connection with the implementation of Support Activity No1b had discussed the further hotspot work with Mr Igor Koniukhov, finding that the Murmansk HEG being ready to arrange a HEG meeting in early September (possibly 2<sup>nd</sup> or 3<sup>rd</sup> of September) but can also look for alternative dates.
- b) Planning of the regional HEGs updating of Screening & Analysis reports and exclusion plans.
  - Arkhangelsk (remaining A1, A3-2, **A5**, <u>A6+A8</u>, <u>A7</u>, <u>A9-1</u>, <u>A9-2</u>): Based on the HEG meeting in Arkhangelsk during April 2019, the up-date of the situation is fairly ok, giving that **A5** is cleared for exclusion by SHE (see SHE#78) and if the necessary preparations are done,





- probably also **9-1**. SHE has requested Arkhangelsk HEG to submit up-dated Screening & Analysis Reports for the merged <u>A6+A8</u> as well as for <u>A7</u> and for the split <u>A9-1</u> and <u>A9-2</u>.
- ii) Karelia (remaining K2, K3 <u>K5</u>, K6, K7, K8, K9): Based on earlier communication, SHE can assume <u>K5 a candidate by full-track exclusion</u>, through the Suppport Activities No4+5. Since no HEG meeting took place so far, no other indications were detected from the Karelian HEG.
- iii) Komi (remaining Ko1, <u>Ko3-2</u>, Ko4, Ko5, Ko6, Ko8): Based on earlier communication, SHE can assume <u>Ko3-2 a candidate by full-track exclusion</u>, through the Suppport Activities No4+5. Since no HEG meeting took place so far, no other indications were detected from the Komi HEG.
- iv) Murmansk (remaining M1, M2, M3, M4, M5, M6, M7, M9, M10): Based on received letters and complementary discussions in Murmansk in June 2019, Murmansk has claimed intentions for excluding M3, M4, M5, M6 and M10, all by fast track. Updated S&As are necessary for all.
- v) Nenets AO (remaining N1, N2, N3): Based on earlier discussions, the Nenets HEG has expressed interest to work actively for the exclusion of N3 by full-track, starting with Supporting Activities No6+7. Discussions are made further via NEFCO.

<u>It was decided</u> to arrange a longer (3-4 hours) SHE-meeting in September to focus especially on the hotspots and their progress.

### 6. Follow-up and Decisions on further steps with the Support Activities

- a) Review of Conducted and Soon Implemented Support Activities
  - i) It was agreed that the final report from the No1b Seminar in Murmansk was approved by whole SHE (Alexander approved via e-mail just after the meeting).
- b) Review and up-date of experts in the thematic Task Forces and Technical Expert Committees

It was concluded that the list still needs to be up-dated with contact information (in particular e-mail addresses ) and in some cases also some experts. It is important that these up-dates are mad till SHE #83.

- c) Review of the ToRs for Support Activities received Principle Approval for Funding:
  - i) ToR for Support Activity No2+3 for Pulp and Paper Sector
  - ii) ToR for Support Activity No2+3 for Wastewater Treatment Sector
  - iii) ToR for Support Activity No2+3 for Contaminated Soils
  - iv) ToR for Support Activity No4+5 addressed for Ko3-2 Mondi Syktyvkar & K5 Petrozavodsk WWTP.

TF has reported that Mondi Syktyvkar has expessed an interest in having the Support Activity No4+5 sometime between 30 September – 7 november. TF will give more specified dates by the 24<sup>th</sup> of August. <u>It was recognised that</u> the ToRs listed in SHE#81.6ci-iv were principally approved already at SHE#81 and that details such as dates, agendas, programmes etc. be specified later.

- v) ToR for Support Activity No6 addressed for A3-1 Severodvinskiy HPP
- vi) ToR for Support Activity No6 addressed for M3 OAO Apatity
- vii) ToR for Support Activity No6 addressed for M4 Apatitskiy HPP
- viii) ToR for Support Activity No6 addressed for M5 Kovdorskiy GOK
- ix) ToR for Support Activity No6 addressed for N3 Wastewater Treatment in Naryan-Mar





x) ToR for Support Activity No9 on Energy Savings and Reduced Climate Impact on a Set of Barents Hotspots. Comment was received to relate the hotspots climate impact to that of the regions' under section D.

Comments had been received regarding the Draft Tor on Support Activities No6 and No 9, icnl:

- Add definitions in the beginning of the document of the different teams (External Experts Team / Consultant Team etc. (Åke)
- HEG Requests should be subject to approval by SHE
- Specify the time period under section 8, i.e. the "medium time result of the assignment"-part.

It was agreed (by Sweden, Finland and Norway during the meeting and by Russia later by e-mail) that the ToRs listed in SHE#81.6cv-x are principally approved with the comments submitted before the meeting. A refined draft with the comments incorporated should be submitted to SHE and regarded approved according to silent procedure within a week from distribution.

<u>It was further agreed</u> that for the Murmansk HEG, SHE approves Support Activities No6(+7) also to hotspots M6, M7 and M10, in addition to M3, M4 and M5.

- d) Decision on the further drafting of Support Activities into complete ToRs, e.g:
  - i) It was agreed to table the discussion on ToR for Support Activity No10 on Communication Workshop to a later SHE-meeting where the IBS can attend as well.

# 7. WGE and Communication Issues

The discussion on this topic was tabled to a later SHE-meeting where the IBS can attend as well. Rickard and Åke will get in contact with Julia (IBS) during the summer to get a progress report.
