4. Review of Minutes from previous meetings

It was concluded that the Minutes from SHE#85 were not yet completed and thus agreed to postpone the review and approval till next meeting.

5. Up-date on Correspondence with the Regional Hotspot Exclusion Groups (Regional HEGs)

a) Follow-up on communication with the regional HEGs incl. their readiness for conducting HEG meetings in the regions/or on telephone

 $\underline{\it It\ was\ concluded}$ that Karelian HEG proposed to have a HEG meeting via Skype on the 14th of November 2019 at $08.00-11.00\ CET$

The Chair reported that in connection with the conduction of the Thematic Seminar (SuppAct 2) on Pulp and Paper Industry in Syktyvkar on 2-4th of October 2019, he had had a side meeting with minister Polshvedin, explaining the details in the Step 3-7 of the hotspots exclusion procedure and what correspondence that shouyld take place between HEG and SHE during the implementation of Support Activity No4+5. During this meeting, the possibility for arranging a HEG meeting was also discussed and it was agreed that Minister Polshvedkin will link up with Alexander Druchinin and hopes to arrange a Komi HEG meeting on telephone or Skype in end of October 2019.

From Arkhangelsk, Murmansk and Nenets AO, no news were reported.

b) Follow-up of the regional HEGs updating of Screening & Analysis reports and exclusion plans:

The docmentation status and preparedness for exclusion of the remaining hotspots was reviewed and found as presented in the table below:

iii) Komi: Ko1, <u>Ko3-2</u>, Ko4, Ko5, Ko6, Ko8)

iv) Murmansk: (remaining M1, M2, <u>M3</u>, <u>M4</u>, <u>M5</u>, <u>M6</u>, <u>M7</u>, M9, <u>M10</u>)

v) Nenets AO: (remaining N1, N2, N3)

c) Decisions on actions to be taken by SHE to assist and promote the documentary work of the HEGs, aiming for deserving hotspots to be excluded at the XIV Ministerial Meeting in Luleå on the 4-5th of February 2020

It was agreed to:

- i) Prepare document package and initiate a TEC-review on A9-1 (Rickard)
- ii) Send clear instructions to the BAT-bureau, <u>Karelian HEG and K5-representatives</u> on the order of necessary documents, who should send it and when (Åke/Rickard)
- iii) Send clear instructions to the BAT-bureau, <u>Komi HEG and Ko3-2-representatives</u> on the order of necessary documents, who should send it and when (Åke/Rickard)

6. Follow-up and Decisions on further steps with the Support Activities

- a) Review of Conducted and Soon Implemented Support Activities
 - i) <u>It was agreed</u> that the Summary Report on all five No1b Seminars was approved
 - ii) It was concluded that the report from the No2 Activity Thematic Seminar on Pulp and Paper Industry in Syktyvkar had been distributed shortly prior to the meeting and <u>it was agreed</u> that the report should be approved by silent procedure till the 28th of October 2019. Prior to that, possible comments should be sent to SHE.
 - iii) It was concluded that the report from the No2 Activity Thematic Seminar on Water and Wastewater Industry in Petrozavodsk had been distributed shortly prior to the meeting and <u>it was agreed</u> that the report should be approved by silent procedure till the 28th of October 2019. Prior to that, possible comments should be sent to SHE.
 - iv) Regarding the progress of the Support Activities No6 addressed for M3-M7 and M10, Henrik Forsström reported that due to the uncertainties regarding the contracting, no news on this could yt be reported. Since this issue now has been solved, *it was agreed* that Henrik contacts the consultants in Murmansk to get a good update of the progress and a clear understanding of the dates when the Screening & Analysis reprots could be delivered and possible Criteria Setting Meetings held.
- b) Review of the ToRs for Support Activities received Principle Approval:
 - i) The ToR for Support Activity No4+5 addressed for Ko3-2 Mondi Syktyvkar was reviewed and discussed.
 - ii) The ToR for Support Activity No4+5 addressed for K5 Petrozavodsk WWTP was reviewed and discussed

For the further development of as well the ToR for Support Activity No4+5 addressed for Ko3-2 - Mondi Syktyvkar as for the ToR for Support Activity No4+5 addressed for K5 - Petrozavodsk WWTP





<u>it was agreed that</u> claryfying guidelines are provided incl. a) how the No4+5 activities correlate with the hotspot exclusion procedure, b) instructions on what is expected from whom and when as well as c) ot use the SHE format for the ToR (Åke)

<u>It was also agreed that</u> a somewhat more detailed budget be requested from the TF on Permit Granting and that Mikael Lundholm as TF Chair should copy both the TF on WWTP and TF on Pulp and Paper when refining the two ToRs. (Mikael Lundholm)

- c) Decision on the further drafting of Support Activities into complete ToRs, e.g.
 - i) Regarding the further drafting of ToR for Support Activity No6 addressed for N3 Wastewater Treatment in Naryan-Mar, it was concluded that due to flooding at the government authority building in Naryan-Mar no progress had been made.
 - ii) Regarding the further drafting of ToR for Support Activity No9 on Energy Savings and Reduced Climate Impact on a Set of Barents Hotspots it was conlcuded that no progress was made.

Henrik Forsström from NEFCO reported that an internal meeting had taken place at NEFCO a few hours earlier, i.e. on October 21, clarifying procedural issues so that the contracts with the BAT-bureau and other consultants involved in the Suport Activities could be signed. It was further approved that the Barents Hot Spot Facility (BHSF) at NEFCO can be used for funding Supporting Activities also for the next two years.

7. WGE and Communication Issues

a) Up-date from the TF On Communication

Julia reported that the TF on Communication held a meeting on the 14th of October 2019, where they concluded that the TF will give priority to refine the ToR on the Video Productions. For the Communication workshop, the concept as well as possible dates will be further elaborated by the group in dialogue with communication colleagues in the regions.

<u>It was agreed that</u> Åke and Rickard will produce a draft 'narrative' for a general video about the history of the Barents exclusion process and the work done.

b) Discussion and Decision on Orange labelling of K5 and Ko3-2 and how this should be facilitated

The function of the colour classification of the Hotspot Exclusion Procedure as means for encouragement and announcement of progress of the hotspot owners systematic and cooperative work, was discussed. The Chair reminded about the <u>systematic administrative</u> work in Steps 3 – 5 shall justify "orange" labelling of a hotspot and the <u>systematic physical</u> work in Steps 6-7 shall justify the hotpots being labelled as "yellow".

<u>It was concluded</u> that Petrozavodsk WWTP and Mondi PPM in Syktyvkar through their participation in Support Activities 4+5 now enter a phase of systematic administrative work through criteria definition, action planning (via EPEP) and approval of the action plan, which bring them through Steps 3-5 of the hotspots exclusion procedure.

<u>It was agreed</u> that in follow of this, the colour labelling for K5 and Ko3-2 should be changed from red to orange in a) the hotspot map and b) the table at the IBS web-site (Julia). <u>It was also agreed</u> that c) a news flash should be drafted (Åke/Jessica/Anders and Kristina) to be published on the Barents website.

c) Feedback and advices on the usability of the SHE-library at SharePoint

It was concluded that all participants had successfully tried to get access to the SHE Platform at SharePoint and looked forward to have the platform enriched also with a more complete set of SHE documents.
