# The key topics of the Russian Chairmanship of the Barents Euro-Arctic Council in 2015-2017

- Transport and logistics
- Environment and climate
  - Culture and tourism

#### Transport and logistics cooperation

- Development of effective, safe and sustainable cross-border transport and logistics networks. All-regional approach to planning and implementation of transport initiatives
  - Adoption of the Joint Barents Transport Plan which implies establishment of 12 cross-border corridors covering 3 means of transport: motor, railway and sea transport
    - Establishment of the East-West air connection in the European North. Making use of commercial advantages of the Northern Sea Route

<u>Key event</u>: Meeting of Ministers of Transport of the BEAC member states in Arkhangelsk and Meeting of Steering Committee of the Barents Euro-Arctic Transport Area (BEATA) (Arkhangelsk, June 2016)

#### Environment and climate cooperation

- Further elimination of environmental 'hot spots' in the Barents Euro-Arctic region.
- Cooperation in water resources conservation, clean production and ecologically sustainable consumption, along with ecological education and dissemination of best environmental practices.
  - Implementation of phase II of the Barents Protected Area Network project (BPAN)
- Further implementation of the BEAC Climate Change Action Plan adopted at the meeting of Ministers of Environment of the BEAC member states (Inari, Finland, 4-5 December 2013)

<u>Key event</u>: Meeting of Ministers of Environment of the BEAC member states in Sortavala, Karelia (24-25 November 2015)

#### Culture and tourism cooperation

- Enhancement of cultural and creative industries as a tool for dynamic social and economic development of the Barents Euro-Arctic region
- Promotion of cultural diversity, exchanges and multicultural dialogue with a view to increase communication between people. Preserving of cultural and ethno cultural heritage in the Barents region
  - Strengthening of Barents identity, promotion of 'the Barents brand'.

    Development of a format and nominating procedures for the Barents scholarship in culture
  - Establishment of favorable conditions for ecologically, socially and culturally sustainable tourism in the Barents region
- Intensifying of cooperation in tourism industries, extending of the Barents tourism potential to the highest international standards

<u>Key event</u>: Meeting of Ministers of Culture of the BEAC member states in Moscow (Summer 2016)

#### Other spheres of cooperation

- economic and business cooperation (including development of Barents Forest Sector Network)

- energy
- healthcare
- science and education
  - youth policy
- emergency and rescue
  - customs services

- increasing regional cooperation between indigenous peoples, ensuring their rights and interests, providing them with proper living and working conditions, including conditions for traditional activities
